



The EMA Wednesday Report

Wednesday, March 25, 2020

Good Morning/Good Afternoon:

We have created the "Wednesday Report" to keep you informed on the latest resources from Federal, State, and Local Government on the COVID-19 Outbreak. We are using the KYSS principle to keep it simple and current. Each report will provide you the latest information that we have on a Wednesday-to-Wednesday period. The reason for this timing is that Federal Task-Forces meet on Monday and Tuesday and Industry Task-Forces meet on Friday, so Wednesday is the best day for us to provide you information.

We will also host a series of webinars on each COVID-19 Bill coming out of Congress so you know where to get resources and/or additional information. Our Public Affairs Team and our lobbyists will conduct these webinars. You can help us by ensuring that one member of your local team is on these calls at all times.

A Few Quick Points:

- Every envelope plant is a part of the key mailing industry. In some states, you are known as the converting industry and in others the mailing industry. Just know that you are covered and you are a part of the key infrastructure to keep things going right now. This has all been coordinated with various Federal Agencies and State Office of the Governors. We have provided you with a letter from the USPS on this matter. If you are stopped for any reason, show them this letter. It is provided at this link: USPS Letter on Key Mailing Industry.
- The COVID-19 virus does not live on mail. The USPS has ensured that the mail that is delivered
 is safe. Please ensure that your envelope boxes are sealed when they leave your plant, just like
 we did during anthrax.
- Keep plants and work areas clean and disinfected. The virus can attach to metal surfaces, so
 please keep work areas clean (more information on disinfecting below). Tell your customers that
 you are open for business and ready to receive orders. Many of your competitors are using social
 media to do this, but whatever way you normally communicate with them, please let them know.
- Follow social distancing guidelines in your plant and home. The CDC website linkage below will help you with useful information.
- The latest reports from the USPS will be on the postal service website. Please use the link below.
